PANEL 1: NATO in the next decade: Providing peace and security in a challenging security environment



Yordan Bozhilov, President of Sofia Security Forum

Yordan Bozhilov holds a Master's degree in Political Science and a Master of Law. In 1992 he began his career in the Ministry of Defense of the Republic of Bulgaria. His professional career goes successively through all grades and positions. As an expert and senior expert he worked on the coordination of the Ministry of Defense with the other ministries and the Council of Ministers. He was subsequently appointed Chief

of the Chancellery Department. As such, he managed the entire documentary work of the Ministry and was responsible for the development and implementation of a number of information systems. In 2002-2003, he completed a course at the Geneva Center for Security Policy. On his return he was appointed Chief of International Organizations and Arms Control Department of the Ministry of Defense. As such, he represented the Ministry of Defense in a number of international organizations. From 2005 to 2008, he was the Director of the International Cooperation Directorate, responsible for the bilateral relations of the Ministry of Defense and the participation of the Ministry in international organizations. He has led the negotiations and the conclusion of bilateral defense agreements. From 2008 until the beginning of 2010, he was the Deputy Director of the Defense Policy Directorate. Between 2005 and 2008 he represented Bulgaria in various NATO working groups. In 2008 he worked as Chairman of the Multinational Advisory Group of RACVIAK – Centre for Security Cooperation, Zagreb.

In the period 2010-2013 he served as Chief of the Cabinet of the Minister of Defense. Since 2013 he has been working as an analyst in the Bulgarian Academy of Sciences and is Chairman of the Sofia Security Forum, a non-governmental organization, working in the spheres of security, defense, international relations and the training of young leaders.

Yordan Bozhilov has many publications on the issues related to the defense and security, NATO and EU, Black sea security and stability, terrorism, etc. He is a commentator for different media and often invited as a lecturer to various national and international events.



Colonel Orlin Nikolov assumed duties as Director of the Crisis Management and Disaster Response Centre of Excellence (CMDR COE) on 10 January 2019.

The mission of the CMDR COE is to act as a catalyst for the enhancement of NATO, NATO Nations' and Partners' capabilities in crisis management and disaster response operations through collaborative partnerships.

As a Director, Colonel Nikolov is responsible for developing and executing the Centre's strategic objectives in line with organisation's mission and vision. He is leading the

process of preparing and implementing comprehensive activity plans, setting priorities and managing the process of elaboration for the CMDR COE' Programme of work.

Colonel Nikolov previously served as Chief of Capabilities Branch, CMDR COE; Chief Expert in "Exercise and Training", MOD; Senior Assistant in "Simulations" branch in the General Staff; Assistant in "Doctrines and training programs" branch in Training Directorate in the General Staff; Deputy Chief of National Center for Modeling and Simulations, Chief of AAR team - National Military Training Complex "Charalitza"; Head of Staff; Head of Technical Staff; Senior Technical Officer – Air Defense Unit.

Colonel Nikolov graduated in 1991 from the High military school "P.Volov" - Shumen, Bulgaria. In 2003 he

earned his Master from National Defence College "G.S. Rakovski"-Sofia, Bulgaria. He completed Junior Staff Officer Course – Liptovski Mikulash, Slovakia in 2005, and Joint Specialized Operation Course in Joint Specialized Operation University, USA. Colonel Nikolov has PhD in National Security presenting "Ways for improving of education and training for crisis management and disaster response". He is an author of many articles and feature on Air Defense and Modeling and Simulations thematic. Colonel Nikolov is a member of distinguished NATO Modeling and Simulation Groups.

The main projects Colonel Nikolov was engaged with are the Establishment and development of National Centre for Modeling and Simulation "Charalitza"; Establishment and development of Integrated System for M&S in MoD; Project Manager for acquiring systems and tools for E&T (JCATS, VBS2, DITS, JEMM, JPECT, JEST, other); Project Manager of project for Establishment and development of CMDR COE; Project Manager of project for Establishment of South Eastern Europe Education and Training Network; Project Manager of project for Investigate and assess M&S Decision Making Support and Data Analysis platform for CMDR and Climate Change.



FLOTILLA ADMIRAL PROF. Dr. Dsc BOYAN MEDNIKAROV,

Rector of Nikola Vaptsarov Naval Academy, Professor of Military-Political Aspects of Security, Chairman of the Scientists' Union in Varna, member of the Management Board of the Bulgarian Union of Scientists and an active public figure.

Flotilla Adm. Prof. Boyan Mednikarov, D.Sc. graduated first in class in the Naval Academy in Varna, specializing in naval shipping guidance. He started his service at the light infantry brigade in the city of Sozopol, as a Commander of a rocket launcher. Subsequently, he went through the positions of Assistant Commander, Ship Commander, Commander of a tactical group of ships, Chief of division of ships. The Admiral Kuznetsov Naval Academy in St. Petersburg awarded him a gold medal, when he obtained his first Master's degree in 1992.

During his extensive professional career, he has held the positions of a Senior Assistant Chief of the Operations Division at the Navy Headquarters in Varna, Deputy Head of the Operational-Tactical Department of the Postgraduate Qualifications Center at the Naval Academy, Head of the Naval Forces Department at the Military Academy. Between 2001 and 2011, he was the Deputy Head of the Educational and Scientific Section of the Naval Academy in Varna. Since May 2011, he is the Rector of the Academy.

In 1999, he completed his Doctorate degree and later became an Associate Professor of Armed Forces Organization and Management. Flotilla Adm. Prof. Mednikarov has his second Master degree in Strategic Leadership of Defense and Armed Forces from the Military Academy in Sofia. He has a second PhD in Military-Political Aspects of Security. Since 2009, Flotilla Adm. Prof. Mednikarov is a Professor in the same academic field.

Prof. Mednikarov was the chairman of the Scientists' Union in Varna. He is a winner of the Varna Award for Science in 2008 in the field of social sciences. He was awarded the 2014 Prize of the Bulgarian Marine Chamber St. Nicholas for personal contribution in the development of marine science and education. Honorary Professor of the Naval Academy Mircea cel Batran, Constanta, Romania. Awarded with the Honorable Golden Order "Merit to Varna" in 2016 for the overall contribution to the development of marine education and science. Winner of the 2016 Black Sea Medal Awards for the long years of work in the field of conservation and improvement of the Black Sea environment. He was awarded a Doctor Honoris Causa Degree by Todor Kableshkov University of Transport, Sofia.

Nicola de Santis, Head Engagements Section, NATO Public Diplomacy Division

Nicola de Santis was appointed, as at 1 September 2019, by the Secretary General of NATO, Jens Stoltenberg, Head of the Engagements Section in the Public Diplomacy Division of the NATO Headquarters in Brussels, which aims at promoting security cooperation through a variety of programmes in NATO member nations and in partner

countries, contributing to a continuous process of international security debate and policy creation. In this capacity, Mr. de Santis is responsible for leading and managing the Alliance's public diplomacy activities and programmes, to promote a better understanding of NATO, its values, policies and activities, fostering dialogue and cooperation with relevant audiences in NATO and partner countries.

Prior to that, he was for nine years the Head of the Middle East and North Africa Section in the Political Affairs and Security Policy Division of the NATO Headquarters in Brussels, where he was responsible for developing and promoting NATO policy, political relations, individual practical cooperation programmes and public diplomacy activities, with Middle Eastern and North African countries, especially those participating in NATO's Mediterranean Dialogue (MD) and in the Istanbul Cooperation Initiative (ICI). He also ensured coordination with all other Divisions of NATO's International Staff, International Military Staff and relevant NATO Military Authorities, for all aspects of NATO's cooperation with countries in the Middle East and in North Africa.

During his more than two-decade career at the Brussels NATO Headquarters, which he joined in 1991 following international competition, Mr. de Santis served under seven NATO Secretary Generals, in different senior executive policy and communications positions. He has a deep knowledge of NATO and many years of extensive international experience, especially in establishing and managing high level cooperative relations and projects between NATO and its member countries, PfP, Mediterranean and Middle Eastern countries; advising NATO Secretary Generals and Deputy Secretary Generals on high level political relations with these countries and conducting high level negotiations for international agreements with them. Nicola de Santis has as well a thorough experience of working in concert with other NATO Divisions and Military Authorities, including during the NATO crisis management arrangements of the military crises of Bosnia, Kosovo and particularly of Libya, during which he was in charge of sensitive political and military aspects of this crisis managed by NATO upon UN mandate.

Mr. de Santis, joined the Office of the Secretary General (OSG), Office of Information and Press (OIP), on 1 November 1991, following international competition, as head of the NATO Countries' Academic Affairs, in the External Relations Section, a position he was appointed to by then Secretary General Manfred Woerner, in order to establish NATO's cooperative ties with strategic studies centers, international affairs institutes and think tanks doing work in international and security affairs, in all of the then 16 NATO member countries. Following another international competition, he was appointed in January 1994 as Briefing and Liaison

Officer Italy, External Relations Section, OSG, OIP, in charge of NATO's relations with Italy, establishing and maintaining contacts with government authorities, political parties, parliamentary committees dealing with foreign and defense policies, trade unions, opinion leaders and the media. He was also designated Briefing and Liaison Officer for Spain (a.i.).

In November 1994, he was dual-hatted as Officer for Southern and Eastern Mediterranean Countries, External Relations Section, OSG, OIP, in charge of outreach activities to the seven Middle Eastern and North African countries members of the Mediterranean Dialogue, since its establishment in December 1994. In October 2001, following another international competition, the Secretary General of NATO Lord Robertson appointed Nicola de Santis to the post of Information Officer for Mediterranean Dialogue and Partner Countries, in the Outreach and Partner Relations Section, OSG, OIP, in charge of NATO's relations and projects with governments, political leaders, parliamentarians, academics and the media of the seven Mediterranean Dialogue countries. In September 2004, he became the NATO Public Diplomacy Division Coordinator for the Mediterranean Dialogue and for the Istanbul Cooperation Initiative.

On 1 January 2006, then NATO Secretary General Mr. Jaap de Hoop Scheffer, following promotion, appointed Mr. de Santis to the position of Head Mediterranean Dialogue and Istanbul Cooperation Initiative Countries Section, in the NATO Public Diplomacy Division, reporting to the Assistant Secretary General for Public Diplomacy and to the Secretary General of NATO. In January 2011 he was appointed by NATO Secretary General Anders Fogh Rasmussen as the Head of the Mediterranean Dialogue and the Istanbul Cooperation Initiative Countries Section in the Political Affairs and Security Policy Division and in July 2012 as Head of the Middle East and North Africa Section in the Political Affairs and Security Policy Division.

For his distinguished service at NATO Headquarters, he was awarded the Cross of Grand Officer of the Order of the Merit of the Star, the Cross of Commander of the Order of the Merit of the Star by the President of the Republic of Italy and the Cross of Knight of the Order of the Civil Merit by the King of Spain. He is, among others, a member of the London based International Institute of Strategic Studies (IISS) and Rome based the Centro Studi di Politica Internazionale (Ce.S.P.I.). He lectures regularly at high level international events representing NATO. His previous positions before joining NATO included: Director of the Transatlantic Program of the Alcide De Gasperi Foundation in Rome; Research Fellow on Middle Eastern conflicts and terrorism at the Italian Society for International Organisation (S.I.O.I.), in Rome; Parliamentary Assistant to the Chairman of the Defense Committee and Secretary of the Intelligence Committee of the Italian House of Deputies; Special Programs Officer at the NATO Defense College, in Rome. He undertook his political science graduate studies at L.U.I.S.S. international university in Rome; he holds as well a post graduate diploma from the S.I.O.I. Advanced School for International Civil Servants in Rome.



General (ret.) Constantin Popov,

Chairman of the Defense Committee and member of the Committee on Internal Security and Public Order of the 44th National Assembly of the Republic of Bulgaria

General Constantin Popov was born in 1961 in Sofia. During his military career he has gone from junior pilot in a fighter squadron, Commander of a fighter air base, through Commander of the Air Force and Deputy Chief of Defense to Chief of Defense of the Republic of Bulgaria.

He has over 1200 flight hours on L-29, MiG-15, MiG-17, MiG-21, MiG-29.

General Popov is one of the first senior Bulgarian officers who worked in a NATO HQ. He was Chief of Staff, NATO Joint Force Training Centre in Bydgoszcz, Poland in the period 2005 – 2006. From 2006 to 2008 he was assigned Deputy Chief of Staff of the Allied Air Component Command Headquarters, Izmir, Turkey.

General Popov was elected to the Bulgarian Parliament in April 2017 upon his retirement of active service.

General Popov holds a Master's Degree in Strategic Studies from Air War College, Maxwell Air Force Base, Alabama, USA and a Ph.D. in Organization and Management of the Armed Forces from "G.S. Rakovski" National Defense College, Sofia. He is also a Member of the Union of Scientists in Bulgaria.

His national decorations include, inter alia, the order "Stara Planina" – first grade, with swords, the Medal of Honor "St. George the Victor" – first grade, the "Commendation Medal for Meritorious Service under the

Colors", the "Commendation Medal for Contribution to the Ministry of Defense", awarded to him for his distinguished service and professional achievements.

In recognition of his work in Bydgoszcz he was awarded the "Golden medal of the Polish Armed Forces".

General Popov is married to Liliya and they have three grown-up children – a daughter and twin boys. He enjoys reading history books.



Atanas Zapryanov,Deputy Minister of Defence, Bulgaria

Lieutenant General Atanas Zapryanov (Ret.) was born on 16 April 1950 in the village of Dragoynovo, Plovdiv District. In 1965, he graduated from the specialized high school in mechanical engineering in the town of Plovdiv. In 1974, Atanas Zapryanov graduated from Vassil Levski military school of higher education in Veliko Turnovo as diploma engineer, earning a Master's degree in the specialty Signal Troops. He was distinguished as the

best graduate ranking first among the alumni of the year at the military school. In 1982, he earned a Master's degree in military science and warfare at Budyoni Military Academy of Communications, Saint Petersburg, Russia, from which he graduated, earning a gold medal for his high academic achievements and an excellent—grades diploma. He earned a Master of Science degree in Strategic Management of the Armed Forces at the General-Staff Faculty of the G. S. Rakovski National Defence Academy, from which he graduated in 1995.

In his academic and professional career as a military officer of the Bulgarian armed forces, in 2001 Atanas Zapryanov completed Senior Information Manager Course and a Manager in Information Protection Infrastructure Course at the Information Resources Management College to the National Defense University, Washington, USA, where he was nominated as an alumnus of honor in the College's Hall of Fame for high achievements earned during his military service. Atanas Zapryanov also completed the Senior Course at NATO Defence College in Rome, Italy.

In the course of his military career, Lieutenant General Atanas Zapryanov has held different command and staff positions in the Signal troops of the Bulgarian army: platoon commander, company commander, deputy battalion commander, chief of staff and deputy commander of 95th signal regiment of Second army in Plovdiv, department senior assistant to the department head at the Land Forces Command, department head, chief of staff, deputy director and director of Signal Troops Directorate to the General Staff of the Bulgarian Army (until 2002). As a senior military officer, he also held the positions Commandant of G. S. Rakovski National Defence Academy, Deputy Chief of Staff of the Bulgarian Army for resources until 2006, and a military representative of the Chief of General Staff at NATO military committees and the European Union (until 2010).

After joining the military reserve, since 2010, he has been a counselor to two political cabinets of the Minister of Defence (until 2013) and since 2015 until July 2016, Deputy Minister of Defence since July 2016 until 30 January 2017.

Lieutenant General Atanas Zapryanov (Ret.) has been awarded multiple times for excellent military service and high professional results; he was awarded For Military Merit Order, First Degree.

Atanas Zapryanov speaks Russian and English. He is married and has two children.

Mircea Geoană became NATO Deputy Secretary General in October 2019, after a distinguished domestic and international career. Mr Geoană is the first Deputy Secretary General from Romania, and the first from any of the countries that joined the Alliance after the end of the Cold War.

Mr Geoană was born in Romania on 14 July 1958. He studied at the Polytechnic University in Bucharest, the Faculty of Law of the University of Bucharest, the Ecole

Nationale d'Administration in Paris, and he holds a PhD from the Economic Studies Academy of Bucharest. Mr Geoană has served as a diplomat and a politician, and in 2009 was his party's candidate to be President of Romania.

PANEL 3. Providing NATO with new capabilities in the new technological environment.



Dr. Shalamanov

After 19 years in military, followed by an academic career in the Academy of Sciences **Dr. Shalamanov** has several tours of public service: Deputy Minister of Defense (1998-2001), Minister of Defense (2014) and Director Demand Management in the NATO's IT and Cyber Agency (2009-2017). In 2019 he was elected as a Chair of the Agency Supervisory Board facilitating the consensus among 30 nations.

Since 2018 Velizar is deputy director of the Institute of Information and Communications Technologies, focusing on consolidation of the academic cyber capacity in Bulgaria and EU (under H2020 project) and study of best practices for effectiveness, efficiency and cyber resilience of IT organizations, role of IT in institutional change management. IT related research work of Dr. Shalamanov started in 1984 as a project manager, head of section and sector in defense institute, leading intelligent planning and assessment systems development, followed by some projects in space research, institutional change management, integrated command and control / emergency management systems, computer assisted exercises. He defended the PhD thesis in Kiev (1991) and became Associated Professor in 1998.



Dr Bryan WELLS

As of 1 July 2019, the North Atlantic Council (NAC) appointed Chief Scientist is Dr. Bryan Wells (UK). In this role, he has three major responsibilities. First, he serves as Chair of the NATO Science and Technology Board (STB). In this context, he serves as the STB's representative to the Secretary General and the NAC and is responsible to the STB for the effective coordination of NATO's Science and Technology (S&T) program.

Second, he serves as the senior scientific advisor to NATO leadership, ensuring that appropriate and timely S&T based advice is provided to NATO senior decision makers. Finally, he leads the Office of the Chief Scientist at NATO Headquarters.

Prior to his appointment as Chief Scientist, Dr. Wells was the UK Ministry of Defence's Head, of S&T Policy, Strategic Research and International Engagement. His responsibilities included the provision of strategic policy advice on the international and research aspects of the Ministry's science and technology programme.

Additionally, he has recently completed a three-year term (2016-2018) as Chair of the European Defence Agency's Research & Technology Steering Board.

Dr Wells joined the UK Ministry of Defence in 1988. He served as Assistant Private Secretary to the Secretary of State for Defence 1989-1992, and has held a range of other posts, including Deputy Director of NATO Policy 1997-1999, and Director of Counter-Proliferation and Arms Control 2002- 2008. During 1999-2002 he was on secondment to the Lord Chancellor's Department (now the Department of Justice) as Head of Administrative Justice.

Dr Wells was educated at St Catherine's College, Oxford (1978-85) and Merton College Oxford (1985-1988). He graduated BA(Hons) in Chemistry in 1982 and was awarded a DPhil in 1985. He conducted three years post-Doctorate research at Oxford University as a Junior Research Fellow at Merton College.



Col. Luca Guaragno works since 2017 in the EU Military Staff where, leading the Force Capability Branch, he provides analytical advice, methods and document drafting in support of the EU Common Security and Defence Policy to the Political and Military strategic level.

In his duties, he compares what the EU "NEEDS" in terms of military capability requirements to what the EU "HAS", in force of Member States contributions, and designs a way ahead for the fulfilment of the EU military Level of Ambition (LoA) on security and defence.

To this purpose he has fostered in 2018 the creation of a specific set of the EU "High Impact Capability Goals", enhancing the understanding of the EU LoA and setting a military reference of strategic importance for the EU institutions and Member States in the capability planning field.

In light of the recent EU momentum towards Security and Defence, his responsibilities have been enlarged to encompass the new EU initiatives of the so called "EU Defence package", where:

- as vice President of the EUMS **PESCO** Task Force, he contributes to the assessment of PESCO projects and National Implementation Plans submitted by EU Member States;
- runs for the EUMS all **CARD** activities, including bilateral consultations with Member States and drafting in close coordination with the EDA the Final Report for the Ministers of Defence;
- represents the EUMS main PoC for all Defence related initiatives launched by the Commission (PADR, EDIDP, EDF, Financial Toolbox..).

This broad spectrum of his duties and responsibilities requires him to liaise at political-diplomatic and strategic military level within the **EU institutions** (EUMC, PMG, PSC, DG ECHO, DG MOVE, DG GROW, ECFIN, EDA, JRC..) and unceasingly cooperate with **NATO** entities and the **Academic world** in Brussels and many other sites in Europe.

Col. Guaragno has served for 28 years in the Italian Air Force, where, after a long operational **career as combat and instructor pilot** on fast jet and transport aircrafts, he has worked in the education and training field as a class commander in the Air Force Academy and gained a considerable expertise in the national military capability planning area, fulfilling several duties and key positions in the Air Force Head Quarters. In 2015 and 2016 he worked on the periodical revision of the Italian Air Force mid and long term capability development plan in coherence with national, NATO and EU General Planning guidance.
